

RESOLUTION NO: 2021-1407

A RESOLUTION REPEALING AND REPLACING THE ENGLEWOOD AREA FIRE CONTROL DISTRICT RESOLUTION NO. 2013-1354 ESTABLISHED IN 2013 ELECTED TO USE THE UNIFORM METHOD OF CHARGING FEES FOR SPECIAL EVENTS WITHIN THE DISTRICT; STATING A NEED FOR SUCH LEVY; PROVIDING FOR THE MAILING OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of the Englewood Area Fire Control District that fire protection services be readily available; and

WHEREAS, the Englewood Area Fire Control District Fire Commissioners (the "Board") shall establish reasonable fees and regulations necessary for the provision of fire protection services (Florida State Statute 191.009), and

WHEREAS, the Englewood Area Fire Control District has conducted a reviewed of fees charged by other entities in reference to "Special Event Fees", and

WHEREAS, the Englewood Area Fire Control District finds the fee schedule (Exhibit "A") of "Special Event User Fees" reasonable to recover the District's administrative costs.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE ENGLEWOOD AREA FIRE CONTROL DISTRICT;

Section 1: Commencing on March 24, 2021 the Englewood Area Fire Control District intends collect fees for "Special Events" in accordance with the attached exhibit "A"


Section 2: This Resolution shall take effect March 24, 2021.

Special Event User Fees

Englewood Area Fire Control District charges the following fees for Special Events within the District.

<i>Fire Engine with 3 personnel:</i>	<i>\$235.00 per hour</i>
<i>Ladder Truck with 3 personnel:</i>	<i>\$235.00 per hour</i>
<i>Fire Boat with 4 Personnel:</i>	<i>\$265.00 per hour</i>
<i>Command Vehicle:</i>	<i>\$100.00 per hour</i>
<i>Light Tower:</i>	<i>\$40.00 per hour</i>
<i>Firefighter Personnel:</i>	<i>\$50.00 per hour per firefighter (not with vehicle)</i>
<i>Fire Inspector</i>	<i>\$ 45.00 per hour</i>
<i>Required Site Inspection</i>	<i>\$ 75.00 per Inspection</i>

**User fees could be waived for the District participation in District sponsored events or Community events when approved by the Fire Chief. (Local school and daycare visits are exempt)*
